This is a seminar, so I will help set the stage with some lectures, but mostly it's your show. I'll intervene to keep the discussion on track and to provide precision when needed. And of course I'm available for office hour discussion.

Requirements:

- 1. Each student will be a discussion leader for an hour during two separate meetings. As a discussion leader you will present a portion of the text and a secondary piece (article or book chapter) relevant to the discussion. Use a handout, outlining your points and providing correct bibliographic references for the secondary literature you discuss. 5% per session; 10% total.
- 2. Each student will write a mid-term paper discussing *Discipline and Punish*, *History of Sexuality I*, and "Society Must be Defended." This should be expository, aiming for clarity and accuracy in relaying main themes. Think of it as an introductory lecture for an undergraduate course. 12 pages; 20%.
- 3. Each student will write a term paper. This should be thesis-driven, supporting a narrow, arguable claim about Foucault's work. You should demonstrate working knowledge of relevant secondary literature. 20 pages; 50%.
- 4. Each student will make a 15 minute conference-like presentation on the topic of their term paper. 20%.
